

Right of Withdrawal for Consumers

(A consumer is any natural person who enters into a legal transaction for purposes that predominantly are outside their trade, business, or profession.)

Instructions on Withdrawal

Right of Withdrawal

You have the right to withdraw from this contract within 14 days without giving any reason. The withdrawal period is 14 days from the day

- on which you or a third party designated by you, who is not the carrier, have taken possession of the goods, provided that you ordered one or several goods as part of a single order and these are delivered together;
- on which you or a third party designated by you, who is not the carrier, have taken possession of the last good, provided that you ordered several goods as part of a single order and these are delivered separately.

To exercise your right of withdrawal, you must inform us (KCC GmbH, Brunnenweg 19, 64331 Weiterstadt, Germany, Phone: +49 6150-9709230, E-mail: withdrawal@somnia24.com) of your decision to withdraw from this contract by means of a clear declaration (e.g. a letter sent by post or an e-mail). You may use the attached model withdrawal form, but this is not mandatory.

To meet the withdrawal deadline, it is sufficient that you send the notification of your exercise of the right of withdrawal before the withdrawal period expires.

Effects of Withdrawal

If you withdraw from this contract, we shall reimburse you for all payments that we have received from you, including delivery costs (except for any additional costs resulting from your choice of a type of delivery other than the least expensive standard delivery offered by us), without undue delay and no later than 14 days from the day on which we receive notification of your withdrawal from this contract.

For this reimbursement, we will use the same means of payment that you used for the original transaction, unless expressly agreed otherwise with you; in no case will you be charged any fees for this reimbursement.

We may withhold reimbursement until we have received the goods back or until you have provided proof that you have returned the goods, whichever is earlier.

You must return or hand over the goods to

without undue delay and in any event no later than 14 days from the day on which you inform us of your withdrawal from this contract. The deadline is met if you send the goods before the 14-day period has expired.

You bear the direct costs of returning the goods.

You must only pay for any diminished value of the goods if this loss in value is due to handling of the goods that was not necessary to examine the nature, characteristics and functioning of the goods.

Exclusion or Early Expiry of the Right of Withdrawal

The right of withdrawal does not apply to contracts:

- for the supply of goods that are not prefabricated and for whose manufacture an individual selection
 or determination by the consumer is decisive, or which are clearly tailored to the personal needs of the
 consumer;
- for the supply of goods which are liable to deteriorate rapidly or whose expiry date would be quickly exceeded:
- for the supply of alcoholic beverages, the price of which was agreed upon at the time of the conclusion of the contract, but which cannot be delivered before 30 days after the conclusion of the contract and whose current value depends on market fluctuations beyond the trader's control;
- for the supply of newspapers, periodicals or magazines, except for subscription contracts.

The right of withdrawal expires prematurely for contracts:

- for the supply of sealed goods which are not suitable for return for reasons of health protection or hygiene and whose seal was removed after delivery;
- for the supply of goods which, after delivery, have been inseparably mixed with other items due to their nature;
- for the supply of sealed audio or video recordings or sealed computer software if the seal was removed after delivery.
